#### UGC'S NORMS ON RECRUITMENT AND QUALIFICATIONS

- \* The minimum qualifications required for the post of Assistant Professor, Associate Professor, Professor, Senior Professor, Principal, Assistant Librarian, Deputy Librarian, Librarian, Assistant Director of Physical Education and Sports, Deputy Director of Physical Education and Sports and Director of Physical Education and Sports, shall be as specified by the UGC in these Regulations.
- \* The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/SET) shall remain the minimum eligibility for appointment of Assistant Professor and equivalent positions wherever provided in these Regulations. Further, SLET/SET shall be valid as the minimum eligibility for direct recruitment to Universities/Colleges/Institutions in the respective state only:

Provided that candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulation, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or any equivalent position in any University, College or Institution.

Provided further that the award of degree to candidates registered for the M.Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been awarded by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

- \* The clearing of NET/SLET/SET shall not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted.
- \* A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.

- \* A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differentlyabled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The above norms of the UGC are subject to the concurrence of the Government of Tamil Nadu.

## (to apply for the post of Assistant Professor and Associate Professors) COMMON TO ALL THE DEPARTMENTS

- 1. Candidates must be Indian Nationals.
- 2. Qualifications and other conditions prescribed and notified by the MHRD / UGC.
- 3. Scale of Pay: As per UGC's Pay Scales as approved by the Government of Tamil Nadu.
- 4. Age Limit: Not more than 57 years as on the date of advertisement.
- 5. i. Application form, details of qualifications and instructions to the candidates are available at <a href="www.tnteu.ac.in">www.tnteu.ac.in</a>. The candidates who satisfy the above requirements can download the applications from the said website. A crossed Demand Draft to the value of Rs.500/- and Rs.250/- for SC/ST candidates (non-refundable) towards the cost of application and registration fees shall be sent along with the application. However, SC/ST applicants should produce an attested copy of the Community Certificate obtained from the competent authority to avail for concession. All Demand Drafts should be taken on/after the date of advertisement in favour of "The Registrar i/c, Tamil Nadu Teachers Education University" payable at Chennai.

The applications of the candidates with the following discrepancies will be rejected summarily at the admission stage itself without any notice and no communication will be entertained in this regard.

- (a) Incomplete and ineligible applications, (b) Applications without THREE copies and (c) Applications which are not forwarded through the respective employers (d) The applications received after the last date is over.
- ii. The last date for receipt of filled in applications is 27.09.2018 upto 5.00 p.m. The University will not be responsible for any postal delay. It shall be so arranged that application sent through proper channel is also received in this office on or before the last date prescribed.

- 7. New Contributory Pension Scheme will be applicable for the new entrants and also for the staff who were recruited on or after 01.04.2003. (G.O.Ms.No.439/Fin/2004, dated 06.08.2004).
- 8. Applications unaccompanied with Demand Draft towards cost of application and attested copies of testimonials will be rejected without any notice.
- 9. Persons who want to avail the benefit of reservation under the Differently abled category will have to submit the Disability Certificate issued by the Competent Authority in the prescribed format.
- 10. The prescribed qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview. The University reserves the right to shortlist the candidates based on merit.
- 11. Applications from candidates, who are in service, should be sent through proper channel. The candidates shall send 3 copies of the applications as per the advertisement. They shall bring 6 more copies of the applications for placing before the member of the Selection Committee. The applications through proper channel shall be submitted to the Office of the Registrar, if not already sent. Their application will be considered and they

will be permitted for the interview only if their applications are forwarded through proper channel are received in time. If not, such application will be rejected without any notice. Otherwise they should produce No Objection Certificate obtained from the employer at the time of interview, failing which the applicant will not be permitted to appear for the interview.
