Item No. 2

In the letter No.10494/J2/2017-1, dated 13.07.2017 the Principal Secretary to Government, Higher Education Department, Government of Tamil Nadu has requested to implement section 32 of the Right of Persons with Disabilities Act, 2016 which provides as follows:


- 32(1) *All Government Institutions of Higher Education and other Higher Education Institutions receiving aid from the Government shall reserve not less than five percent seats for persons with benchmark disabilities.*
- (2) *The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions in higher education.*

The Syndicate at its meeting held on 25.10.2017 has already approved for adoption of section 32 of the Right of Persons with Disabilities Act, 2016, for reserving not less than 5 percent of seats for persons with benchmark disabilities and relaxation of 5 years on upper age limit to the persons with benchmark disabilities which has been implemented for admission of students for the year 2017-2018 to M.Ed Degree Programme offered by the University.

Dr.M.Govindan will move that the section 32 of the Right of Persons with Disabilities Act, 2016 for reserving not less than 5 percent of seats for persons with benchmark disabilities and relaxation of 5 years on upper age limit to the persons with benchmark disabilities be implemented for admission to B.Ed., B.Sc.B.Ed/ B.A.B.Ed., M.Ed., M.Phil and Ph.D Degree Programmes offered by the University, Government and Government Aided Colleges of Education affiliated to this University.

Accordingly, the following provisions of the section 32 of the Right of Persons with Disabilities Act, 2016 be incorporated in the Regulations of B.Ed., B.Sc.B.Ed/B.A.B.Ed., M.Ed., M.Phil and Ph.D Degree Programmes.

- 1. The University shall reserve not less than five percent seats for persons with benchmark disabilities.*
- 2. The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions in higher education.*

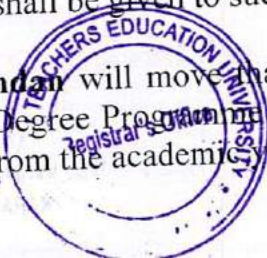

MINUTES OF THE MEETING

Vice Chancellor: I wish very good morning to all the eminent members of the Academic Council.

The Meeting is called in order.

I am extremely happy to welcome the new members of this August Body to this Meeting.

I welcome Dr.P.Nithila Devakarunyam, Dr.T.Kanakaraj, Dr.S.Santhi, Tmt.M.A.Muniammal, Mrs.K.Dhanalakshmi and all the members to this Academic Council Meeting and request the members to offer their suggestions and views for the development of the University.

The Tamil Nadu Teachers Education University is significantly improving in growth and expansion. The University Departments of Study and Research are involved in constant and consistent research activities by organizing seminars, workshops for the understanding of new issues in the field of education.

I am very glad to inform this August body that MHRD has sanctioned a Project on Pandit Madhan Mohan Malviya National Mission on Teachers and Teaching with financial grant of Rs.5.25 crores to Dr.M.Govindan, Head of the Department of Educational Psychology to establish Faculty Development Centre at our University. I congratulate Dr.M.Govindan. He took a lot of efforts in bringing the project for our University and I appreciate his genuine interest in teacher development and he has been rewarded at the National Level. I congratulate Dr.M.Govindan.

The Indian Council of Social Science Research has sanctioned Rs.1.75 Lakhs for organizing a National Seminar on "Skill Development and Goal Setting Strategies for Urban and Rural Students" to Dr.P.C.Nagasubramani, Associate Professor, Department of Pedagogical Sciences. Now, let us take the first agenda on incorporation of certain Regulations in the B.Ed Curriculum and introduction of RTI Act 2005 as one of the subjects. I think you have received the Agenda. We have sent the Agenda to all by email. Have you gone through the Agenda? Have you any suggestions in the first agenda.

Dr.V.Balakrishnan: As the Chairman of the Board of Studies for B.Ed Degree Programme Dr.V.Balakrishnan after wishing the members of the house presented that the Board of Studies for B.Ed Degree Programme at its meeting held on 04.10.2018 resolved to recommend as follows:

1. that the RTI Act, 2005 be incorporated as a subject in the B.Ed Curriculum and be added as one of the components of the Unit.III of the Theory course 2 Contemporary India & Education-IV:
2. that the students be permitted to avail the opportunity of transferring their course of study from one institution to other institution provided that:
 - they be permitted by the University from where their recognition is sought.
 - the opportunity be availed only once during the course of study.
 - both the institutions involved in the process of transfer shall issue No Objection Certificates.
 - the sanctioned strength of the programme and course of study shall not exceed the permitted strength by the University and NCTE Norms (i.e. either one/two unit strength)
 - permission be accorded only after completion of first year of study.
 - no student be permitted for transfer in the middle of the academic year, and.
 - the students be transferred among the similar categories of colleges of education only, like self-financing college to self-financing college.




