To consider the Re-do the Course – II year admission to be incorporate in the Syllabus and Regulations for M.Ed programme.

Notes:

It is submitted that, each candidate whose appearance in examination is approved by Tamil Nadu Teachers Education University after gaining 85% (i.e., 170 days) of attendance in every academic year, failing which they will not be permitted to appear for the Degree Examination.


However, as per the decision of the Syndicate of Tamil Nadu Teachers Education University in its meeting held on 10.08.2010 candidates who are able to gain attendance only upto 75% on medical ground, will be permitted to appear for the examination, after getting condonation of attendance, adhering to the norms of Tamil Nadu Teachers Education University.

The University has started receiving requests from the second year students who have not gained 75% of attendance to complete their studies. There is no specific direction in the University Regulation for such students, whether they may continue their second year course in the next academic year from the same college or not.

The matter is placed before the Board of Studies for M.Ed Programme for consideration.



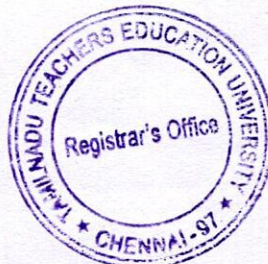
It is submitted that, the qualification prescribed by the NCTE for the appointment of Assistant Professors in Colleges of Education is as follows:

- (1) *A Master degree in Science/Arts/Humanities with 55% or an equivalent grade in a point scale wherever grading system is followed and*
- (2) *M.Ed. with atleast 55% of marks or an equivalent grade in a point scale wherever grading system is followed.*

In this regard, a lot of complaints has raised from the candidates that if he/she has secured less than 55% become ineligible for the post of Assistant professor in Education Colleges and their degree becomes useless.

Now the matter is placed before the Board of Studies for M.Ed Programme for consideration.

Minutes of Meeting of the Board of Studies for M.Ed. Degree Programme held on 05.10.2018

Resolution for Item No.1 in the Agenda:

It is resolved that the students who have not gained 85% attendance in general or 75% attendance on medical grounds either in the first year or second year may be permitted to re-do the M.Ed Programme for the particular year in the same college with the permission of the University (within the course duration of 3 years as per the NCTE norms)

Resolution for Item No.2 in the Agenda:

It is resolved that the students can avail the opportunity of transferring their course of study from one institution to other institution provided that

- they should be permitted by the University from where their recognition is sought.
- the opportunity be availed only once during the course of study.
- both the institutions involved in the process of transfer should submit No Objection Certificates.
- the sanctioned strength of the programme and course of study should not exceed the permitted strength by the NCTE (i.e. either one/two unit strength).
- permission will be accorded only after completion of first year of study.
- no student will be permitted for transfer in the middle of the academic year.
