**Sub:- Decision of SRC in its 387<sup>th</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August, 2020 – regarding.**

Sir,

The Southern Regional Committee (SRC) in its 387<sup>th</sup> meeting held on 24<sup>th</sup>-25<sup>th</sup> August, 2020 decided the following:-

“... The SRC discussed the issue of institution offering Teacher Education programmes without obtaining recognition from the NCTE. In this regard, the Regional Director, SRC, NCTE is advised to write a letter to the Secretary, Education & Director, SCERT of the State / UT in the jurisdiction of Southern Regional Committee to provide the list of such institution in their respective State / UT (if there are any). This may be treated as most urgent.”

On the aforesaid matter, the following instances comes to the notice of the SRC, NCTE which need appropriate action on your part:-

- (i) It has come to the knowledge of SRC, NCTE that State Govt., certain State Universities and State Education Councils has given permission to the educational institutions for running teacher education programme without obtaining recognition from the NCTE which is compulsory mandated by the NCTE Act, 1993.
- (ii) It has also come to the knowledge of SRC, NCTE, that there are certain fake and unrecognized educational institutions who are imparting teacher education programme without obtaining recognition from the NCTE. It is requested that appropriate action may be taken in accordance with law against those institutions and same may also be intimated to SRC, NCTE.
- (iii) The SRC also noticed that even some of the recognized institutions are taking additional intake of students/course for which they have not been given recognition/permission by the SRC, NCTE. The institutions has also submitted fake recognition/permission of additional intake/course to the affiliating bodies and affiliating bodies have been giving affiliation on the basis of fake/forged orders of the SRC, NCTE.

Regarding point No. (i), it is bring to your kind notice that as per National Council of Teacher Education (NCTE) Act 1993, the NCTE is Apex body of Government of India enacted by an Act of Parliament to accord recognition / permission to the teacher training institution in the Country. It is also brought to the attention of your good self about the provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

It is requested that any educational institution which intend to impart teacher training programme has a mandate to obtain recognition order from Southern Regional Committee of NCTE for the Southern States of India. Those institution who offers Teacher Education courses without obtaining recognition / permission from NCTE is illegal as per NCTE Act 1993.

It is further requested that in future no educational institution may be given permission for affiliation by the State Govt. and its affiliating bodies without having valid recognition / permission order from the SRC, NCTE. Action may please be taken against those institution who does not possess recognition order from NCTE to stop running / offering the courses with immediate effect. If any educational institution is running teacher education programme without recognition order of the SRC, NCTE, the same shall be restricted from offering any Teacher Education courses with immediate effect. The list of such institutions may also be sent to the SRC, NCTE in the below format:-

Regarding point No. (ii) & (iii), it is requested that before grant of affiliation to run teacher education programme or increase of intake/course, the same may only be given after due verification of the records of recognition order uploaded in the NCTE website or by ascertaining the facts & figures from the SRC, NCTE as to whether institution(s) has obtained a valid recognition/permission order from the SRC, NCTE. It is informed that the fake/unrecognized institutions can be traced by cross verification of the recognized institutions which is duly provided in the website of the SRC, NCTE [www.ncte.gov.in](http://www.ncte.gov.in)

It is requested that those institutions who by forged means have taken affiliation/additional intake, an appropriate action may also be taken against those institutions in accordance with law and same may also be intimated to the SRC, NCTE.
