As the number of the trainees in D.El.Ed., course is insufficient, it is kindly requested to extend support to the District Level Coordinators (DLCs) by allowing the trainees of B.Ed. and M.Ed. courses and students of Arts and Science Colleges

to discharge their duties as additional Field Investigators in all districts. Further, it is kindly requested to send official communication to your subordinate officials to instruct the Heads of institutions in this regard.
